Healthiest Cities and Counties Challenge

- Aetna Foundation, American Public Health Association, National Association of Counties
 - A highly competitive national grant
- Due May 31st
- Goal: "to develop practical, evidence-based strategies to improve measurable social and health outcomes and promote health and wellness, equity and social interaction community by community, block by block."
- Will the funds go across state lines?—Yes, the definition of community is up to the group applying
 - The population of the community would determine which of the two tiers the project falls under. The Health Collaborative area would be in tier 1
- The challenge aligns with what the Health Collaborative is working towards
- Fiscal Agent—*Possibly* the United Way of Danville Pittsylvania County
- Letters of support—a combination of targeted letters and a declaration of support at the leadership meeting

Does the collaborative need a grant writing committee?

- Different grants will require different insight and areas of expertise so having a formalized group may not be effective
 - Maybe each workgroup needs to write a description of its works, evaluation process and metrics

Channeling New Interest

- Mutual learning and sharing
 - How to collect the energy around events such as Dr. Levine's presentation, Finding Our Roots, etc.?
 - Applicable for workgroups and collaborative as a whole
 - No formal initiation process—invite those that who express interest/ who you think would be interested
 - Need to always have an idea on how people can get involved—is it time for the Collaborative and workgroups to produce welcome/ introductory materials
 - Community presentations
 - Community member groups that we are missing
 - Faith-Based community
 - Better Together Initiative group
 - Physicians Group unique approach
 - Give them the meat to grab their attention—make a specific ask
 - Do not have time for *all* to come together to design and plan
 - However, it would help increase buy-in if there was *a* provider involved in the planning
 - How does the collaborative build physicians into the process
 - Use what is already in existence
 - Tap into current initiatives
 - Plug into their current meetings
 - Actively work to change the point of view of physicians from a physician centered approach to a patient centered approach
